She started her career with Missouri Probation and Parole in 1992 as an officer in St. Louis Mo. She was promoted to a Unit Supervisor in 1997 after

transferring to a field office at the Lake of the Ozark's. In 2003, she was promoted to District Administrator I. She retired in 2021 as a District Administrator V. During her time with Probation and Parole she supervised every type of caseload and carried many extra duties. She served on regional and divisional committees as well as numerous task forces. In 2019, she served as the first Probation and Parole Liaison to the Missouri Highway Patrol Human Trafficking Unit. Mr. Henry Moore is a 27-year veteran with the Little Rock Police Department. Serving as an Officer, he is assigned to the Emergency Management Unit which is responsible for mitigating manmade and natural disasters in the City of Little Rock. His duties also include training of all sworn officers and recruits of the Department. This includes annual in-service training, as well as State and Departmentally mandated recertification courses, Career Development courses, legal updates, and training with issued equipment. Officer Moore also oversees the Department's Active Aggressor program.

Throughout his career, Officer Moore has been assigned to various Divisions which includes Training, Patrol, Special Investigations and Special Operations. Additionally, he has served as a member of the Special Response Unit and has been assigned to the Special Weapons and Tactics Unit Since July of 2000. Officer Moore attended the University of Arkansas at Fayetteville. He also holds a Professional Police Instructor Certification and a Firearms Instructor Certification from the Commission on Law Enforcement Standards and Training as well as an Advanced Hostage Rescue Certification from Combat Shooting and Tactics.
